1. Introduction and presentation

1.1. Foreword:

3. Tender conditions

3.1. Deadline and format

The deadline for bid submission is December 20 th, 2024, 13:59 p.m. Bids can be sent in English or any of the three official Belgian languages. Bids must be sent electronically, in PDF format to the following email addresses:

3.2 Competence and exclusions

The bidder states that he has the technical ability to carry out the entirety of the requested professional activities, including the official registration requirements for its business or profession.

The bidder declares that he is not bankrupt, in liquidation or judicial redress, as well as in a debt collection situation.

The bidder states that no judicial court decision has been made final against it, during a labor and social security infringement procedure.

The bidder and members of its management state that they have no business connection or degree of kinship or alliance with PES AISBL management or employees, nor any kind connection that could lead to a conflict of interest.

Associated to this procedure, the tenderer PES AISBL does not request a proof of status and legal capacity at this stage of engagement but reserves the right to do so at a later stage, if it deems it required.

By submitting an offer, the bidder hence confirms being in accordance with all conditions specified in point 3.2, at the time of submission.

Contrarily, the tenderer can reserve the right to either refuse acceptance of bid submission, revoke contract allocation, as well as retroactively annul all eventually signed contracts with liable party, with the latter accepting denial of any kind of compensation for contract termination.

3.3 Promotion of equal opportunities

Tenderers shall undertake to observe a policy on the promotion of equality and diversity in the execution of the contract, should it be awarded to them, by applying the principles of non-discrimination and equality set out in the European Union Treaties in full and in their entirety.

More particularly, the tenderer awarded the contract shall undertake to establish, maintain and promote an open and inclusive working environment which respects human dignity and the principles of equal opportunities and the removal of all obstacles to recruitment and all potential discrimination based on sex, race or ethnic origin, religion or convictions, disability, age or sexual orientation.

4.1. Overview of services to be rendered

A description of the services to be provided, as mentioned in point 2, also including but not limited to:

- Streamlined invoicing process preferable by digital means
- Access to a platform for our accounting department to retrieve invoices, purchase orders and other accounting-related information. Automatic upload of invoices/credit notes in our ERP system Exact global will be an asset
- At the request of the Finance Director, be able to give clear and structured management information regarding travel that has taken place or will take place or then make it possible to retrieve this information directly from a platform







5. Contract award criteria for financial offer

The objective of the award criteria is to evaluate each tender's quality and the "best value for money" ratio, as to better discern the optimal solution for the tenderer.

Tenders are evaluated based on a "point system" award criteria as defined in the below categories.

Dedicated team/emergency service team	2 points
Value for money pricing	2 points
Detailed and transparent pricing system.	2 points

6. Notifications of results and suspension of proceedings

6.1. Notifications and information

The decision and award of the contract will be notified to all bidders, by email, latest by end of January 2025.

The contract will be awarded for 4 years with the possibility of a 1-year renewal maximum. Cancellation can be done at any time, following an agreed procedure between the parties.

Please mention clearly your company's cancelation procedure if one exists.

6.2. Suspension of proceedings

In the event of force majeure, at any time prior to the signing of the contract by both parties, the PES/PES AISBL may decide to suspend the proceedings and postpone the contract's award decision at a later date, without any of the parties being able to request any form of compensation.

By force majeure, one can understand, but not limited to, any circumstance that may prevent the decision-makers from being able to finalize the procedure, independently of their will
